IT'S THE LAW
(ORC 955.21)
All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag.
(The law applies regardless of whether the dog is kept inside or out.)

Register your dog on-line at www.co.demo.oh.us. Credit card payments only; \$2.00 per dog processing fee applies. To access your pre-filled form you will need your Account ID and Password listed below.

IN PERSON OR BY MAIL

- Complete this form. Be sure the correct owner, street address, and pet description(s) appear on all applications.
- Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form. Ohio law requires a license for every dog more than 3 months old.
- If you no longer own the dog(s) please contact our office or mark through the appropriate line below and return the form so we can update our records.
- Enclose a check or money order for the correct fees payable to: Demo County Auditor. Please do not send cash. **Before January 31**, licensing rate is **\$12.00 per dog; \$60.00 for Kennel fees** (applies to kennels only). **After January 31**, statutory late penalty increases the licensing rate to **\$24.00 per dog; \$120.00 for Kennel fees** (applies to kennels only). Your application cannot be processed without the correct fees.
- Please return the application, check or money order, and a self-addressed stamped envelope in the enclosed return envelope. A receipt will be returned to you with your 2010 license tag(s).

You may purchase the tag(s) in person at the Demo County Auditor's Office, 123 East Main Street, Demo City or at the Dog Shelter, 1234 Shelter Ave, Demo City. Please bring the attached form when purchasing tags.

Certificate of registration and registration tags shall be valid only during the CALENDAR year IN which they are issued, AND DURING THE FIRST THIRTY-ONE DAYS OF THE FOLLOWING CALENDAR YEAR. ORC. Sec. 955.09.
